WHEREAS, the members of the Sangguniang Panlungsod of Malolos elected during the May 13, 2019 Local Elections formally assumed office on noon of June 30, 2019;

WHEREAS, changes in the modern world, technology and internet connectivity is a new mode of communications which is fast, reliable and convenient to end-users which can be utilized and adopted in the administration of Local Government Units (LGU's) and its respective Sanggunian;

WHEREAS, to make the voting requirements uniform in the provisions as laid down under City Resolution No. 71-2019 there is a need to amend and update the same;

Now, on motion of Hon. Nino Carlo C. Bautista, duly seconded by all Members present

Be it resolved, as it is hereby resolved to amend the Internal Rules of Procedure of the Sangguniang Panlungsod 2019-2020 (Rule VII Section 17, Rule IX Sections 27, 30, 31 and 32) of the City of Malolos, to wit:

SECTION 1. The provisions under Rule VII Section 17 of City Resolution No. 71-2019 is hereby amended to include the following:

"The City Council may hold its Regular Sessions or Special Sessions through internet connectivity using applications that can be used as virtual communication channel such as but not limited to ZOOM App., Messenger, among others, provided that the majority of the Members present concur to the same and for extra-ordinary circumstances such as but not limited to, during the state of Public Health Emergency, State of Emergency, State of Calamity, among others.

Further, the Members of the City Council may cast their respective votes using the abovementioned virtual app during the said Regular or Special Session".

SECTIONS 2. Rule IX of the same is hereby amended as follows:

"Section 27. Creations of Standing Committees - The Sanggunian shall create standing committees each composed of a Chairman, Vice-Chairman and three (3) members. The standing committees may from time to time be reorganized by a majority vote of all the members of the Sanggunian".

Section 30, 31 and 32 shall include the following:

Each Committee may conduct Committee Hearings, Meetings and Public Hearing using virtual apps during Emergency Cases as mentioned under Section 1 hereof and upon concurrence of the Majority of the Members of the Committee.




