CITY RESOLUTION NO. 94-2020

A RESOLUTION RESPECTFULLY REQUESTING THE BOARD OF DIRECTORS OF THE CITY OF MALOLOS WATER DISTRICT (CMWD) AND PRIME WATER INFRASTRUCTURE CORPORATION TO WAIVE THE PAYMENT EQUIVALENT TO AT LEAST ONE MONTH BILL OF ALL CONCESSIONAIRES IN THE CITY OF MALOLOS.

WHEREAS, on March 9, 2020, the Philippines declared the rapid spread of the Novel Corona Virus Disease (COVID-19) as a public health emergency;

WHEREAS, on March 11, 2020, the World Health Organization has characterized the spread of the disease as a pandemic as it continues to spread throughout the world;

WHEREAS, as of May 3, 2020, 9,223 people have been infected and 607 have died of COVID-19 in the Philippines based on Department of Health data;

WHEREAS, as of May 3, 2020, the Provincial Government of Bulacan has recorded one hundred eighteen (118) confirmed cases, twenty-four (24) deaths, 150 probable cases, and 790 suspect cases, twelve (12) of which came from the City of Malolos based on the City Health Office;

WHEREAS, on March 12, 2020, the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases of the National Government issued Joint Resolution No. 11 for the management of the COVID-19, providing for strict social distancing guidelines, including suspension of classes, prohibition on mass gatherings, community quarantine, and restriction of domestic and international travel;

WHEREAS, the City of Malolos Water District (CMWD) and Primewater Infrastructure Corporation is tasked and mandated by law to supply potable water for domestic and for human consumption in the City of Malolos;
