CITY ORDINANCE NO. 01-2023

AN ORDINANCE AMENDING SECTION 1 OF THE CITY ORDINANCE NO. 33-2012, "AN ORDINANCE PRESCRIBING FEES AND CHARGES FOR THE USE OF THE CITY OF MALOLOS FITNESS CENTER AND FURTHER CREATING A TRUST FUND OUT OF THE FEES AND CHARGES DERIVED THEREAT TO COVER ITS MAINTENANCE AND OPERATING EXPENSES" AND RENAMING THE "CITY OF MALOLOS FITNESS CENTER" TO THE "CITY OF MALOLOS FITNESS AND REHABILITATION CENTER".

BE IT ENACTED by the Sangguniang Panlungsod ng Malolos in a session duly assembled, to wit:

SECTION 1. - AMMENDMENT OF SECTION 1 OF CITY ORDINANCE NO. 33-2012 - Section 1 of City Ordinance No. 33-2012 is hereby amended and shall be read, to wit:

"Section 1- FEES and CHARGES

a. It is hereby prescribed the following fees and charges on the use of the facilities at the facilities at the City of Malolos Fitness Center:

Membership Fees:

For City Government of Malolos Employee	100.00 per annum
For Resident of the City of Malolos	300.00 per annum

Fitness Center Charges:

For City Government of Malolos Employee	20.00 per session
For Resident of the City of Malolos	60.00 per session

b. Any bonafide resident of Malolos who intend to stay fit and healthy and who are required for medical reasons to use the fitness facility shall request in writing his intention for the free use of the facility. The following documents shall be attached thereat; Letter of Recommendation of the Attending Physician; Medical Abstract; Certificate of Residency in a barangay for a period of not less than six (6) months; and, Barangay Certificate of Indigency. The City Health Officer shall evaluate and recommend all requests to the City Mayor for his approval".

SECTION 2. - The City of Malolos Fitness Center will be renamed and be known as The City of Malolos Fitness and Rehabilitation Center.

SECTION 3. - The City Health Office shall be responsible for the maintenance, control and supervision of the City of Malolos Fitness and Rehabilitation Center. The City Treasury Office shall be responsible for the collection of fees and charges of the Fitness and Rehabilitation Center and other reportorial duties related thereto.

SECTION 4 - EFFECTIVITY - This Ordinance shall take effect upon its approval.
