CITY ORDINANCE NO. 03-2023

AN ORDINANCE PRESCRIBING THE USE AND ISSUANCE OF A TRAFFIC CITATION TICKET, THEREBY AMENDING CITY ORDINANCE NO. 15-2001, OTHERWISE KNOWN AS THE TRAFFIC CODE OF THE CITY OF MALOLOS.

WHEREAS, on December 19, 2001, the Honorable Sangguniang Panlungsod passed City Ordinance No. 15-2001 entitled "ANG BAGONG PATAKARAN AT ALITUNTUNIN PARA SA KAAYUSAN NG TRAPIKO SA BAYAN NG MALOLOS, BULACAN," otherwise known as The Traffic Code of the City of Malolos;

WHEREAS, on September 10, 2008 the Department of the Interior and Local Government and Department of Transportation and Communications issued Joint Memorandum Circular No. 1 s. 2008, which provides:

"3.4 On the Issuance of Citation Tickets

All locally-issued ordinances, orders, rules and regulations should be in conformity with the following policies, standards and limitations:

- a. The LGUs can issue traffic citation tickets but only the LTO and their deputized agents can confiscate driver's licenses. x x x" (Emphasis supplied)

WHEREAS, on September 14, 2022 the Department of the Interior and Local Government issued a memorandum, which provides "To continuously ensure compliance to laws and policies, particularly, on road safety and transportation, the following provision of the DILG-DOTC Joint Memorandum Circular (JMC) No. 01, s., 2008, with subject, Guidelines in the Review of Local Ordinances, Orders, Rules and Regulations Concerning Public Transportation, is hereby reiterated:
 x x x" (Emphasis supplied)

WHEREAS, there is a need to amend the Traffic Code of the City of Malolos to integrate the Department of the Interior and Local Government and Department of Transportation and Communications issued Joint Memorandum Circular No. 1 s. 2008 to clarify and update certain regulations.

NOW, THEREFORE, on motion of **Hon. Therese Cheryl B. Ople**, duly seconded by all the members of the Sangguniang Panlungsod, be it-

RESOLVED, to enact this Ordinance:

SECTION 1. - The Definitions under Section 2 of the Traffic Code of the City of Malolos shall be adjusted and renumbered to accommodate the following definitions:

CITATION TICKET - Ito ay tumutukoy sa isang reklamo o pasabi kung saan ang isang City Traffic Enforcement Officer ay magtatala ng isang pangyayari na kinasasangkutan ng isa o higit pang mga paglabag sa batas ng drayber o taong binanggit.

CITATION OFFICER - Ito ay tumutukoy sa isang tagapangasiwa sa batas trapiko na binabayaran mula sa pondo ng Lungsod ng Malolos”.

SECTION 2. - Section 24 of the Traffic Code of the City of Malolos is hereby repealed and deleted. The numbering of the remaining Sections shall be adjusted accordingly.

SECTION 3. - Section 60 of the Traffic Code of the City of Malolos is hereby amended to read as follows:

“SEKSYON 60. - MGA ALITUNTUNIN SA PAGBIBIGAY NG CITATION TICKET PARA SA MGA LALABAG SA ANUMANG NAITALANG PROBISYON NG KODIGONG ITO - (a) Sa kaso ng mga drayber ng mga sasakyan na lumabag sa anumang naitalang probisyon ng Kodigong ito, ang City Traffic Enforcement Officer o itinalagang tagapagpatupad ng batas trapiko ay dapat ipag-utos na magpresenta ang drayber ng lisensya at/o mga dokumento bilang katunayan ng pagkamay-ari ng sasakyan.

(b) Ang itinalagang opisyal na nagpapatupad ng batas trapiko ng lungsod ay dapat na ilagay ang pangalan, tirahan ng drayber, numero ng lisensya, numero ng plaka, rehistro at ang ahensyang nagbigay ng lisensya sa citation ticket. Dapat din na itakda ng apprehending officer ang partikular na paglabag at magbigay ng kopya ng citation ticket sa taong nahuli.

(c) Ang nasabing citation ticket ay dapat ding maglaman ng impormasyon na mag-aatas sa drayber na magbayad ng kaukulang multa sa loob ng tatlong (3) araw, mula sa araw ng pagkakatanggap ng citation ticket sa Tanggapan ng Panlungsod **na** Ingat-yaman. Ang resibo na katunayan ng pagbabayad ng multa ay dapat isumite sa City Traffic Management Office (CTMO) para sa clearance.

(d) Kung sakaling ang taong nabigyan ng citation tiket ay hindi tumupad sa itinakdang panahon sa kanya, ang CTMO ay maghahain ng reklamo laban sa naturang tao sa tamang hukuman.

Para sa mga paglabag sa trapiko at pagmamaneho, bukod sa pagsasampa ng kaukulang kaso sa korte, ang CTMO ay makikipag-ugnayan sa Land Transportation Office (LTO) upang ipagpaliban ang pag-renew ng lisensya sa pagmamaneho o pagpaparehistro ng sasakyan hanggang sa makuha ang clearance mula sa lungsod”.

SECTION 4. - **IMPLEMENTING RULES AND REGULATIONS** - The City Traffic Management Office shall issue the corresponding Implementing Rules and Regulation (IRR) within thirty (30) days upon approval of this ordinance.

SECTION 5. - **SEPARABILITY CLAUSE** - If for any reason, provision/s of this Ordinance are declared invalid or unconstitutional, the remaining provision/s not affected thereby shall continue to be in full force and effect.

SECTION 6. - **REPEALING CLAUSE** - All ordinance and other issuances, or any part thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. - **EFFECTIVITY CLAUSE** - This ordinance shall take effect upon approval.
