AN ORDINANCE CREATING THE YOUTH DEVELOPMENT OFFICER I POSITION IN THE OFFICE OF THE CITY MAYOR.

WHEREAS, City Ordinance No. 14-2017 provides the local implementation of Republic Act No. 10742 also known as Sangguniang Kabataan Reform Act of 2015;

WHEREAS, City Ordinance No. 14-2017 prescribed the Creation of City Local Development Council of the City of Malolos, Creation of Local Youth Development Office, declaring the Third Monday of June as City Youth Day and other mandated provisions of RA No. 14-2017;

WHEREAS, Section 12 of City Ordinance No. 14-2017 the defined the head of the Youth Development Office with the rank of at least division chief which may be under the Office of the Local Chief Executive, the Office of the Planning and Development, the Office of the Social Welfare, or in any other office deemed appropriate by the Local Government Unit;

WHEREAS, Republic Act No. 7160 provides that the Sanggunian shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from local funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the local government;

WHEREAS, Section 325 of the said Republic Act provides the limitations on personal services wherein a position is not deemed properly created if such had not been fully provided corresponding appropriations for basic salary and other compensation;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MALOLOS IN A REGULAR SESSION ASSEMBLED THAT:

SECTION 1. - PURPOSE - The purpose of this City Ordinance is to establish the office and the plantilla position that shall implement the programs, activities and projects that adhere to the development of youth in the City of Malolos.

SECTION 2. - CREATION OF POSITION - The creation of plantilla positions for Youth Development Office shall be in a progressive manner until such time that a full pledge division can be appropriated accordingly. In the exigency, there shall be a youth development officer under the Office of the City Mayor with the qualifications, salary grade and duties and functions as follows:

Position	:	Youth Development Officer I
Office	:	Office of the City Mayor
Salary Grade	:	SG 10
Education	:	Bachelor's Degree
Experience	:	none
Training	:	none
Eligibility	:	Career Service (Professional) Second Level Eligibility
Number of Position	:	one (1)

Duties and Functions:

- a. Assist in the formulation of local youth development plans
- b. Assist youth organizations in registration program
- c. Assist in the election and meetings of Local Youth Development Council
- d. Recommends trainings of youth and youth organizations
- e. Prepare and coordinate with concerned agencies programs and projects for the youth sector
- f. Maintain data of youth in the City of Malolos
- g. Perform other duties as may be assigned from time to time


