CITY ORDINANCE NO. 21-2023

AN ORDINANCE REQUIRING ALL CONVENIENCE STORES OPERATING 24 HOURS A DAY (24/7) WITH MINIMUM CAPITALIZATION OF 5 MILLION TO HIRE SECURITY GUARDS, PROVIDING PENALTIES FOR VIOLATION HEREOF AND FOR OTHER PURPOSES.

EXPLANATORY NOTES

WHEREAS, Section 5 of Article 2 of the 1987 Philippine Constitution provides the maintenance of peace and order, the protection of life Liberty and property and the promotion of the General Welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991, provides that every Local Government Units (LGUs) shall implement programs and projects for the General Welfare and development of its constituents;

WHEREAS, it is the primary duty of the City Government of Malolos to protect the best interest of its constituents;

WHEREAS, Public Order and Security is one of the priority areas of the City Government of Malolos;

WHEREAS, the City is committed and serious in its fight against criminality;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Malolos in Session assembled, that:

SECTION 1. - MANDATE - All Convenience Stores operating 24 hours a day (24/7) in the City of Malolos with minimum capitalization of 5 Million Pesos are hereby required to hire Security Guards within ninety (90) days from effectivity of this Ordinance.

SECTION 2. - PENALTY - Any person whether natural or judicial who violated the provision of this Ordinance shall be penalized with a fine of P5,000.00 and/or imprisonment of not more than 30 days, and/or revocation of their Business Permit.

In case of juridical entity, the Manager and/or the President shall be held liable.

SECTION 3. - MONITORING - The Business Permit and Licensing Office (BPLD) in coordination with the Philippine National Police (PNP), Malolos Police Station and the Office of the City Information, shall monitor the implementation of this Ordinance, and shall formulate and promulgate its IRR within thirty (30) days from effectivity of this Ordinance.

SECTION 4. - REPEALING CLAUSE - All other laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. - SEPARABILITY CLAUSE - If for any reason, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. - EFFECTIVITY CLAUSE - This Ordinance shall take effect 15 days after approval and full publication as required by Republic Act No. 7160.
