AN ORDINANCE AMENDING SECTIONS 1 AND 2 OF CITY ORDINANCE NO. 13-2023, AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF PASEO DEL CONGRESO-NORTHBOUND SPAN, CITY OF MALOLOS, BULACAN, FOR THE CONSTRUCTION OF NORTH-SOUTH COMMUTER RAILWAY (NSCR) PROJECT (MALOLOS-TUTUBAN) PACKAGE CP02.

WHEREAS, on February 06, 2023, the Honorable Sangguniang Panlungsod passed City Ordinance No. 13-2023 entitled "an Ordinance authorizing the temporary closure of Paseo del Congreso-Northbound Span, City of Malolos, Bulacan for the construction of North-South Commuter Railways (NSCR) Project (Malolos-Tutuban) Package CP02;'

WHEREAS, on April 24, 2023, Sumitomo Mitsui Construction Co. Ltd., contractor of the said project, notified this Honorable body through letter on the minor movement of dates and span of the temporary closure of the said against the requested date and span that was used in the issued City Ordinance;

NOW THEREFORE, on the motion of HON. EMMANUEL R. SACAY, and duly seconded by the Members present,

BE IT enacted by the Sangguniang Panlungsod of City of Malolos in a Session assembled, that:

SECTION 1. Section 1 of City Ordinance No. 13-2023 shall be amended and read as follows:

COVERAGE - In connection with the above-mentioned purpose, Paseo del Congreso-Northbound Span and Southbound Span, City of Malolos, Bulacan be temporarily closed to all vehicular traffic.
