**RESOLVED, AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod in session assembled, to declare operative in its entirety the Annual Budget of Sangguniang Kabataan of Barangay Santor for the Calendar Year 2023 in the amount of One Million, Four Hundred Seven Thousand Six Hundred Twenty-One Pesos and Thirty-Six Centavos (PHP1,407,621.36).
