A RESOLUTION AUTHORIZING THE CITY MAYOR - ATTY. CHRISTIAN D. NATIVIDAD TO NEGOTIATE, IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF MALOLOS, BULACAN, WITH GOVERNMENT FINANCIAL INSTITUTIONS FOR THE GRANT OF LOAN WITH AN AGGREGATE AMOUNT OF SIX HUNDRED MILLION PESOS (Php600,000,000.00) TO FINANCE THE ESTABLISHMENT OF MALOLOS GENERAL HOSPITAL.

**WHEREAS**, Section 296 of the Local Government Code of the Philippines 1991, states that it shall be the basic policy, that any local government unit may create indebtedness, and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program;

**WHEREAS**, Section 458(2)(iii) of the same Code provides that the Sangguniang Panlungsod, upon the majority vote of all the members of the sanggunian, may authorize the City Mayor to negotiate and contract loans and other forms of indebtedness;

**WHEREAS**, Section 8(b)(1) of the same Code further provides that the City Mayor shall exercise those powers expressly granted to him by law, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for the efficient and effective governance of the City and those which are essential to the promotion of general welfare;

**WHEREAS**, one of the priority projects of the City Government of Malolos is the establishment of Malolos General Hospital that will provide health care services for all Maloleños;

**WHEREAS**, to implement this priority project, the LGU-City of Malolos intends to contract a loan with an aggregate amount of Six Hundred Million Pesos (Php 600,000,000.00) with government financial institutions, whoever signifies its intention to grant the loan subject to compliance with certain requirements;

**RESOLVED, AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod in session assembled, to authorize the City Mayor - Atty. Christian D. Natividad to negotiate, in behalf of the Local Government Unit of the City of Malolos, Bulacan, with government financial institutions for the grant of loan with an aggregate amount of Six Hundred Million Pesos (PhP600,000,000.00) to finance the establishment of Malolos General Hospital.
