

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR - ATTY. CHRISTIAN D. NATIVIDAD IN BEHAL OF THE CITY GOVERNMENT OF MALOLOS, TO ENTER AND SIGN INTO A DEED OF DONATION, WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, ENVIRONMENTAL MANAGEMNET BUREAU, REGION III FOR THE 20-FOOTER CONTAINER AND 100L CAPACITY BINS WITH ROLLER TO IMPROVE THE COLLECTION OF COVID-19 RELATED HEALTHCARE WASTES.

WHEREAS, Section 2 of republic Act No. 9003, also known as the Ecological Solid Waste Management Act of 2000 promotes national research and development programs for improved solid waste management resource conservation techniques, more effective institutional arrangement and indigenous and improved methods of waste reduction, collection, separation and recovery;

WHREAS, COVID-19 cases in the country have started to decline but healthcare wastes generated by the situation have continuously become a challenge among cities and provinces. Waste from quarantine, testing and vaccination facilities is significantly increasing which is detrimental to our health;

WHEREAS, the Department of Environment and Natural Resources (DENR), through the Environmental Management Bureau (EMB) donated a 20-footer container with a 4.5-ton capacity and 100L Capacity Bins with Roller to the City Government of Malolos that will improve the collection of COVID-19 related healthcare wastes;

WHEREAS, the City of Malolos has agreed to be a recipient/beneficiary of the said containers that will provide preliminary disinfection and storage of healthcare wastes;

WHEREAS, the objective of this donation is to provide safe and secured containment and storage area for infectious wastes that will address the challenges of improper collection, preliminary disinfection and storage of Personal Protective Equipment (PPE), syringes, vials and other COVID-19 related healthcare wastes;
