MARASIGAN FOR THE PURCHASE/ACQUISITION/PROCUREMENT OF A LOT WITH AN AREA OF ONE THOUSAND SEVEN HUNDRED EIGHTY-TWO SQUARE METERS (1,782 SQ.M.) MORE OR LESS LOCATED IN BARANGAY MATIMBO, CITY OF MALOLOS FOR THE EXTENSION OF BAHAY KALINGA.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every Local Government Units (LGU's) shall formulate programs and projects that will promote the general welfare of its constituents;

WHEREAS, Hon. Christian D. Natividad requested for an authority to sign in behalf of the City Government of Malolos into a Deed of Absolute Sale for the purchase and procurement of a ONE THOUSAND SEVEN HUNDRED EIGHTY-TWO (1,782) SQUARE METERS parcel of land situated in Barangay Matimbo for the use of the City Government's Extension of Bahay Kalinga;

WHEREAS, in year 2013, the family of Mrs. Severina Ramos-Malonzo donated a 1,265 square meters parcel of land for the use of Bahay Kalinga through City Resolution No. 66-2013;

WHEREAS, there is a need for Bahay Kalinga to expand for the City to cater more children who were in conflict with the law (CICL);

WHEREAS, Chapter II, Section 17 (b) states that such basic services and facilities include but not limited to the following: (4) For a City: All the services and facilities of the municipality and province, and in addition thereto, such as: (2) For a municipality: (iv) Social Welfare Services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents and victims of drug abuse; livelihood and other pro-poor


projects; nutrition services; and family planning services, (vii) Municipal buildings, cultural centers, public parks including freedom parks, playgrounds, and sports facilities and equipment, and other similar facilities and (viii) Infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

WHEREAS, Section 22 (c) of Republic Act 7160 provides that before a Chief Executive may enter and sign into any contract in behalf of the Local Government Unit concerned, there is a need for a prior authorization from the local Sanggunian.




