NATIVIDAD, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT WITH THE OFFICE OF THE PRESIDENT, REPRESENTED BY ASSISTANT SECRETARY ADRIAN CARLOS A. BERSAMIN AND ASSISTANT SECRETARY AL-AZREE J. MOHAMMADSALI FOR THE GRANT OF THREE MILLION PESOS (P3,000,000.00) FINANCIAL ASSISTANCE FOR THE IMMEDIATE NEEDS AND CONCERNS OF MALOLOS CONSTITUENTS WHO WERE AFFECTED BY TYPHOON "EGAY" AND "FALCON".

WHEREAS, Section 25, Article 1 of the Republic Act No. 7160, otherwise known as "Local Government Code," provides that the President, upon request of the local government unit concerned, direct the appropriate national agency to provide financial, technical, or other forms of assistance to the local government unit;

WHEREAS, Section 17 (f) of the same Republic Act (7160) states that the national government or the next higher level of local government unit may provide or augment the basic services and facilities assigned to lower level of local government unit when such services or facilities are not made available or, if made available, are inadequate to meet the requirements of its inhabitants;

WHEREAS, Section 2.8 of Office Order No. 2 s. 2016 General Guidelines on the Management and Administration of the Socio-Civic Projects Fund (SCPF) provides that other forms of special assistance, financial or otherwise, may be granted to target individuals, communities, or group beneficiaries for public health, and other socio-civic purposes;

WHEREAS, Office of the President sees need to provide financial assistance to the City Government of Malolos, due to the effects of the southwest monsoons enhanced by Typhoon "Egay" and "Falcon";

WHEREAS, the Office of the President shall release to the City Government of Malolos the total amount of Three Million Pesos (P3,000,000.00), charged against the Socio-Civic Projects Fund (SCPF) which shall scheduled consistently;

Natividad to enter and sign in behalf of the City Government of Malolos into a Memorandum of Agreement (MOA) with the Office of the President, represented by Assistant Secretary Adrian Carlos A. Bersamin and Assistant Secretary AL-Azree J. Mohammadsali for the grant of Three Million Pesos (P3,000,000.00) financial assistance for the immediate needs and concerns of Malolos Constituents who were affected by Typhoon "Egay" and "Falcon".




