WHEREAS, after review the same has been found compliant with the requirements set forth under the Local Government Code of 1991 and other existing laws and issuances;

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in session assembled, to declare operative in its entirety the Annual Budget of Barangay Balayong for the Calendar Year 2023 in the amount of Two Million Nine Hundred Nine Thousand Five Hundred Four Pesos (PHP2,909,504.00).
