WHEREAS, Sangguniang Kabataan of Barangay San Pablo has submitted to the Sangguniang Panlungsod its Annual Budget for Calendar Year 2023 amounting to Seven Hundred Ninety-Four Thousand One Hundred Thirty Pesos and Fifty-Three Centavos (Php794,130.53);

WHEREAS, after review the same has been found compliant with the requirements set forth under the Local Government Code of 1991 and other existing laws and issuances;

NOW THEREFORE, on motion of Hon. Dennis D. San Diego, duly seconded by all Members present

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in session assembled, to declare operative in its entirety the Annual Budget of Sangguniang Kabataan of Barangay San Pablo for the Calendar Year 2023 in the amount of Seven Hundred Ninety-Four Thousand One Hundred Thirty Pesos and Fifty-Three Centavos (PHP794,130.53).
