CITY RESOLUTION NO. 267-2023

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR - HON. CHRISTIAN D. NATIVIDAD, TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS, INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE III, REPRESENTED BY REGIONAL DIRECTOR JONATHAN V. DIRAIN, FOR THE 13TH CYCLE OF SUPPLEMENTAL FEEDING PROGRAM.

WHEREAS, the Supplementary Feeding Program (SFP) is the provision of food in addition to the regular meals to target children ages 2-5 years old enrolled in the Child Development Centers (CDCs) and Supervised Neighborhood Play (SNP) as part of the Department Of Social Welfare And Development's (DSWD) contribution to the Early Childhood Care and Development (ECCD) Program of the government;

WHEREAS, the Department of Education (DepEd) and the DSWD, in consultation with other National Government Agencies (NGAs), Local Government Units (LGUs), Non-Government Organizations (NGOs) and development partners, are mandated by Republic Act No. 11037 also known as 'Masustansiyang Pagkain Para sa Batang Pilipino', to promulgate their respective rules and regulations for the efficient and effective implementation of the National Feeding Program for Public Day Care Centers (PDCCs) or CDCs, Public Kindergarten and Elementary Schools, pursuant to Section 4 of the said law to address undernutrition among Filipino Children;

WHEREAS, under Section 4(a) of RA No. 11037, the CSWD, in coordination with the LGUs, has been tasked to implement a SPF for undernourished children with ages 3-5 years which shall include the provision of at least one (1) fortified meal for a period of not less than one hundred twenty (120) days in a year;

WHEREAS, the General Appropriation Act of 2022 stated that the target outcome of the SFP is 80% malnourished children in CDCs and SNPs with improved nutritional status;

WHEREAS, given the limitation in the purchasing power of most families due to extended effect of the COVID-19 Pandemic and inflation of food commodities, SFP implementation shall assist in addressing the issue of hunger and food security among Filipino children and prevent regression of the current nutritional status of the beneficiaries;

WHEREAS, the City Government of Malolos, as partner of the DSWD in the expeditious delivery of the social amelioration program, shall assist in the implementation of the SFP;

WHEREAS, according to Section 22 (C) of R.A. 7160, otherwise known as Local Government Code of 1991, no contract maybe entered by the Local Chief Executive in behalf of the Local Government Units without prior authorization by the Sanggunian concerned

NOW THEREFORE, on motion of **Hon. Michael M. Aquino**, duly seconded by all Members present

RESOLVED, as it is hereby resolved, to authorize City Mayor - Hon. Chistian D. Natividad, to enter into and sign in behalf of the City Government of Malolos, into a Memorandum of Agreement (MOA) with Department of Social Welfare and Development (DSWD) Regional Office III, represented by Regional Director Jonathan V. Dirain, for the 13th Cycle of Supplemental Feeding Program.
