WHEREAS, Section 333 of Republic Act 7160 otherwise known as the Local Government Code of 1991, states that the Sangguniang Panlungsod as the Legislative Body of the City, shall have the power to review barangay budget ordinances in order to ensure compliance thereof with all the budgetary requirements and limitations provided for by law;

WHEREAS, Sangguniang Kabataan of Barangay Tikay has submitted to the Sangguniang Panlungsod its Annual Budget for Calendar Year 2023 amounting to One Million Eight Hundred Eighty-Six Thousand Six Hundred Fourteen Pesos and Thirty-One Centavos (PhP1,886,614.31);

WHEREAS, after review the same has been found compliant with the requirements set forth under the Local Government Code of 1991 and other existing laws and issuances;

NOW THEREFORE, on motion of Hon. Dennis D. San Diego, duly seconded by all Members present

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in session assembled, to declare operative in its entirety the Annual Budget of Sangguniang Kabataan of Barangay Tikay for the Calendar Year 2023 in the amount of One Million Eight Hundred Eighty-Six Thousand Six Hundred Fourteen Pesos and Thirty-One Centavos (PhP1,886,614.31).
