

WHEREAS, Sangguniang Kabataan of Barangay Ligas has submitted to the Sangguniang Panlungsod its Annual Budget for Calendar Year 2023 amounting to Eight Hundred Eight Thousand Six Hundred Seventy-Two (PhP808, 672.00);

WHEREAS, after review the same has been foound compliant with the requirements set forth under the Local Government Code of 1991 and other existing laws and issuances;

NOW THEREFORE, on motion of Hon. Dennis D. San Diego, duly seconded by all Members present

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in session assembled, to declare operative in its entirety the Annual Budget of Sangguniang Kabataan of Barangay Ligas for the Calendar Year 2023 in the amount of Eight Hundred Eight Thousand Six Hundred Seventy-Two Pesos (PhP808,672.00).
