
WHEREAS, Section 16 of R.A 7160 mandates the implementation of projects and program by the Local Government Units (LGU's) that will redound to the general welfare of its constituents;

WHEREAS, the City Mayor together with the City of Malolos Development Council (CMDC), respectfully requested the City Council to adopt and approved the City of Malolos Development Council Resolution No. 04-2023 which was approved on September 7, 2023;

WHEREAS, the law provides that any amendments to the Comprehensive Development Plan (CDP), Local Development Investment Program (LDIP) and Annual Investment Program (AIP), the Local Development Council shall approve thru Resolution any changes or updates to the aforementioned;

WHEREAS, Art. 182 (d)(1)(ii)of Rule XXIII of the Implementing Rules and Regulations of RA 7160 mandates the Local Development Council (LDC) to formulate medium-term and annual public investment programs;


