WHEREAS, one of the thrusts and commitments of the City Government of Malolos is to provide quality and efficient public services to its people, including but not limited to the establishment of accessible and effective government facilities and institutions,

WHEREAS, in order to promote an inclusive and convenient public office that could cater to the public needs, the City Government of Malolos aims to establish a Government Center that should provide public services necessary to every Maloleños;

WHEREAS, it is envisioned that the City of Malolos Government Center shall bring together several satellite offices of Regional and National Agencies, including other significant public institutions, into a single conducive facility;

WHEREAS, the establishment of such a government-led center will require an exceedingly large amount of funds, therefore a challenge to the City Government of Malolos for the reason of the limited funds vested therein;

WHEREAS, the City Government of Malolos, through our City Mayor Atty. Christian D. Natividad, together with this Honorable body, seeks for the National Government's financial support for the actualization of this project;
