WHEREAS, the CACTSO shall provide the Tourism Information and Assistance/Help Desk with all materials, such as, but not limited to, tourism brochures and flyers, helpful statistics and data, available hotel accommodation and transport services, destinations of interest, and other tourism promotional materials of the City of Malolos;



RESOLVED, as it is hereby resolved, to provide for the establishment of the Tourism Information and Assistance/Help Desk of the City of Malolos.




