WHEREAS, Section 455(b)(1)(vi) of R.A. 7160, otherwise known as the Local Government Code of 1991 states that the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;

WHEREAS, Article 47(a), Rule IX of the Implementing Rules and Regulations of the Local Government Code on the Corporate Powers and Corporate Seal of the Local Government Unit, provides that, unless otherwise provided in the Code, no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian;

WHEREAS, BIR Revenue Region No. 5 against the City Government of Malolos Assessment Nos. 37916 and 22734 composed of deficiency Income Tax, Value Added Tax, Withholding Tax, and penalties for the taxable year 2016 in the aggregate amount of ₱12,182,476.67;

WHEREAS, pursuant to Section 204 of the National Internal Revenue Code of the Philippines, as amended (NIRC), and Revenue Regulation No. 30-2002 which gives the Commissioner of Internal Revenue the authority to compromise, abate, and refund taxes;

WHEREAS, the City Government of Malolos (CGM) supports the efforts of the Bureau of Internal Revenue (BIR) to reduce the cost of litigation as well as to support the drive of the BIR in collecting taxes, CGM will settle its Income Tax, Value Added Tax, Withholding Tax deficiencies based on the compromised amount as a sign of good faith;






