**WHEREAS**, Barangay San Pablo has submitted to the Sangguniang Panlungsod its Annual Budget for Calendar Year 2023 amounting to Seven Million Three Hundred Forty-Four Thousand Three Hundred Thirty-Eight Pesos and Forty-Six Centavos (PHP7,344,338.46);

**WHEREAS**, after review the same has been found compliant with the requirements set forth under the Local Government Code of 1991 and other existing laws and issuances;

**RESOLVED, AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod in session assembled, to declare operative in its entirety the Annual Budget of Barangay San Pablo for the Calendar Year 2023 in the amount of Seven Million Three Hundred Forty-Four Thousand Three Hundred Thirty-Eight Pesos and Forty-Six Centavos (PHP7,344,338.46).




