WHEREAS, Department of Interior and Local Government (DILG)-Department of Budget and Management (DBM) Joint Memorandum Circular No. 01 dated 04 November, 2020 provides updated guidelines on the appropriation and utilization of the twenty percent (20%) of the annual internal revenue allotment for development projects;

WHEREAS, the Local Finance Committee certifies the existence of savings and the availability of funds to realize the Programs, Projects and Activities (PPAs) as mentioned in CMDC Resolution NO. 07-2023;






