**WHEREAS**, Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991 mandates the promotion of the General Welfare of its constituents through programs and projects by the Local Government Unit concerned;

**WHEREAS**, the Local Government Unit plays a vital role in providing for essential infrastructure projects that are necessary for uplifting the quality of life of its citizenry;

**WHEREAS**, infrastructures projects are crucial in promoting economic growth, social development and sustainability in the community;

**WHEREAS**, asphalt overlaying/patching of roads and retrofitting of bridges are essential components of infrastructure projects that are critical for maintaining a safe and reliable transportation and road network of the city;

**WHEREAS**, according to the Budget Operations Manual for LGUs 2016 edition under the Budget Execution Phase, "if an appropriation ordinance contains lumpsum appropriations for capital outlays or describes the projects in generic terms without details such as infrastructure projects, inter-municipal waterworks, drainage and sewerage, flood control and irrigation systems projects, reclamation projects or roads and bridges, there is an obvious need for a covering contract for every specific project that in turn requires approval by the Sanggunian;"

**WHEREAS**, the Sangguniang Panlungsod approved City Ordinance No. 37-2022, an ordinance approving the Annual Budget for Fiscal Year 2023 of the City Government of Malolos with the total amount of Two Billion Four Hundred Seventy-Eight Million, Nine Hundred Seventy-Eight Thousand, Seven Hundred Fifty-Nine Pesos and 42/100 Centavos (Php2,478,978,759.42);
