WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that every Local Government Units (LGUs) shall formulate programs and projects that will promote General Welfare of its constituents;

WHEREAS, the Philippine Society of Mechanical Engineers (PSME) Inc., since its establishment had supported numerous government projects while serving in varying roles in partnership with government-led projects;

WHEREAS, the PSME believes that efforts can be highly effective when strategies were aligned with those in the government;

WHEREAS, the City Government of Malolos is mandated by law to be one of the primary agencies responsible for the proper implementation of Republic Act No 8495, otherwise known as the Mechanical Engineering Act of 1998;


