WHEREAS, the Philippine Constitution, in Article 15, Section 2(b), explicitly affirms the right of children to receive assistance, which encompasses proper care and nutrition";

WHEREAS, the City of Malolos Nutrition Committee has diligently developed and presented the City Nutrition Action Plan for 2023-2025, aiming to address the critical issue of malnutrition within our city;

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) is the country's framework for nutrition action;

WHEREAS, the City Nutrition Committee's Resolution No. 1-2023, which endorses the City Nutrition Action Plan for 2023-2025, has been duly reviewed and recommended for approval by the relevant committees of the City Council;

WHEREAS, the nutrition profile of Malolos City indicates by the 2023 Operation Timbang Plus results revealed serious cases of stunting with a prevalence of 5.92% affecting 989 under five years old children;

WHEREAS, among the same age group, 2.51% or 420 children were wasted and 5.93% or 991 were overweight/obese. Wasting and overweight and obese in Malolos City are considered public health problems using the WHO cut off points on severity and magnitude;

WHEREAS, the City Council acknowledges the importance of this action plan in addressing the malnutrition challenges faced by our community and expresses its commitment to supporting the successful implementation of the City Nutrition Action Plan for 2023-2025;



**RESOLVED**, as it is hereby resolved to approve the City Nutrition Action Plan for 2023-2025.


