WHEREAS, the Government of the Republic of the Philippines (GPH), represented by the Department of the Interior and Local Government (DILG), entered into a Bilateral Agreement with the Government of the Republic of India (GOI), represented by the Embassy of India (EOI), regarding the Indian Grant Assistance for Implementation of Quick Impact Projects (I-QIP);

WHEREAS, the Indian Grant Assistance for Implementation of Quick Impact Projects (I-QIP) seeks to contribute to the economic growth of Local Government Units (LGUs) all over the country, through the enhancement of delivery of basic services, generation of jobs in the community, and strengthening agriculture and business sectors of the locality;

WHEREAS, the I-QIP intends to fund short gestation projects (hereinafter referred to as "Subproject") that will directly benefit local communities, drive local socio-economic development, particularly for, but not limited to, creation or improvement of physical infrastructure such as roads, local community centers, etc. and social infrastructure such as in education, health, sanitation, or community development sectors;
