WHEREAS, Section 22 of RA 7160 highlights the cooperation between Local Government Units and institutions of higher learning to facilitate programs that directly benefit the local populace, a principle echoed in the spirit of the 1987 Philippine Constitution;

WHEREAS, the City Government of Malolos and Bulacan State University have recognized the need for the 'Kids Handa' program to ensure the safety and well-being of children, affirming the mutual goals aligned with the provisions of the Local Government Code and the fundamental values of the 1987 Philippine Constitution;

WHEREAS, an executed Memorandum of Agreement (MOA) between the City Government of Malolos, represented by Honorable City Mayor - Atty. Christian D. Natividad, and Bulacan State University, represented by Dr. Teody C. San Andres, the University President, has been presented, aiming to foster collaboration and shared responsibilities in realizing the 'Kids Handa' program;
