A CITY RESOLUTION GRANTING PERMISSION AND AUTHORITY TO THE CITY MAYOR - ATTY. CHRISTIAN D. NATIVIDAD, TO SIGN AND ENTER INTO AN AGREEMENT (MEMORANDUM OF AGREEMENT) BETWEEN THE CITY GOVERNMENT OF MALOLOS AND THE PHILIPPINE RED CROSS (PRC) AND ALLOCATE THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) TO BE UTILIZED AS THE 'BLOOD INDIGENCY FUND'.

WHEREAS, during the pandemic, the supply of safe blood in Bulacan has been severely affected, leading to an unexpected surge in the demand for blood transfusions among patients. Many residents in Malolos are facing financial constraints and cannot afford blood units.

WHEREAS, an appeal is made by Philippine Red Cross, Bulacan Chapter, for financial support, urging individuals and organizations to step in as "Blood Samaritans" by sponsoring the cost of blood for indigent residents, with a preferred contribution of PHP 100,000, which can provide about 55 units of blood.

WHEREAS, the Philippine Red Cross (PRC) is recognized as an official non-governmental organization and is clearly outlined in Republic Act No. 10072, also referred to as the "Philippine Red Cross Act of 2009." This law defines the PRC's responsibilities in humanitarian and healthcare activities, its relationship with the government, and its designation as a support service for the Philippine government, particularly during times of disasters and emergencies.

WHEREAS, Section 16 of the Local Government Code of 1991 states that, a local government units (LGUs) are empowered to promote the general welfare of their constituents. They have the authority to provide a wide range of services, including health and social services, and may enter into agreements with non-governmental organizations and people's organizations to implement projects and programs that address various community needs.
