CITY RESOLUTION NO. 387-2023

A RESOLUTION REALIGNING THE AMOUNT OF THIRTY MILLION PESOS (PHP30,000,000.00) AND AUTHORIZING THE GRANT AND RELEASE OF SERVICE RECOGNITION INCENTIVE (SRI) FOR F.Y. 2023 TO THE CITY GOVERNMENT OFFICIALS AND EMPLOYEES PURSUANT TO ADMINISTRATIVE ORDER NO. 12 DATED 07 DECEMBER, 2023, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, on 07 December 2023, the Office of the President of the Philippines issued Administrative Order (A.O) No. 12 authorizing the grant of Service Recognition Incentive (SRI) to government officials and employees for Fiscal Year (FY) 2023;

WHEREAS, Section 6, of the same Administrative Order provides:

"Section 6, SRI for Employees in Local Government Units (LGUs).

- a. The grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunian depending on the LGU's financial capability, subject to the PS limitation in the LGU budgets under RA No. 7160 or the "Local Government Code of 1991," and the conditions set forth in Section 2 hereof, at a uniform rate not exceeding Twenty Thousand Pesos (Php20,000.00), chargeable against their respective FY 2023 local government funds. Should the identified funding source be insufficient to cover the full amount of the SRI, a lower but uniform amount shall be paid to all qualified employees of the LGU.
- b. In determining the amount of the SRI, the sanggunians shall exercise prudence and judicious use of government funds, ensuring that the expenditure is reasonable and will not in any way prejudice the delivery of services to the public."






