WHEREAS, the City Social Welfare and Development Office (CSWDO) has submitted a comprehensive Camp Coordination and Camp Management Plan in response to the humanitarian crisis or emergency situation;

WHEREAS, The City Resolution No. 22-2021, Memorandum of Agreement in behalf of the City Government of Malolos with Department of Education (DepEd) for the use of schools as evacuation centers in the City of Malolos was being implemented at the time of Typhoons;

WHEREAS, the plan has undergone thorough review, reflecting a well-thought-out approach to coordinating and managing camps for the displaced population, taking into account the unique needs and challenges presented by the crisis;

WHEREAS, the CSWDO's plan includes essential components such as site selection, infrastructure planning, protection measures, community participation, and the provision of necessary services and facilities for the well-being of the affected individuals and families;

WHEREAS, the plan demonstrates a commitment to collaboration with other relevant sectors, addresses the needs of vulnerable populations, and incorporates monitoring, evaluation, and reporting mechanisms for ongoing assessment and improvement;

NOW, THEREFORE, upon motion of Hon. Victorino M. Aldaba III duly seconded by all Members present,

RESOLVED, as it is hereby resolved, to adopt and approve the Camp Coordination and Camp Management Plan created by the City Social Welfare and Development Office of The City of Malolos.






