**AN ORDER CREATING THE CITY OF MALOLOS ADOLESCENT PREGNANCY PREVENTION COUNCIL**

**WHEREAS**, Section 13, Article II of the 1987 Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being, and states further its role to inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

**WHEREAS**, RA. 10354, otherwise known as the Responsible Parenthood Reproductive Health Act of 2012, stipulates that the State recognizes and guarantees the human rights of all persons including the right to health which includes reproductive decisions for themselves in accordance with their religious convictions, ethics, cultural, beliefs, and the demands of responsible in the country;

**WHEREAS**, on June 25, 2021, former President Rodrigo R. Duterte issued an E.O no. 141, entitled "Adopting as a National Priority the Implementation of Measures to Address the Root Causes of the Rising Number of Teenage Pregnancies, and Mobilizing Government Agencies for the Purpose", which provided instructions to all levels of government to

assist in addressing the issues related to the increasing number of adolescent pregnancies in the country;

**WHEREAS**, City Ordinance 49-2023, otherwise known as the "Malolos Adolescent Pregnancy Protection Ordinance (MAPPO)", established a policy in teenage pregnancies and repeated teenage pregnancies, institutionalizing support and social protection for teenage parents;

**WHEREAS**, Section 4 of City Ordinance 49-2023 mandates the creation of Malolos Adolescent Pregnancy Prevention Council;

**NOW, THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD**, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by existing and applicable law, do hereby order the creation of the City of Malolos Adolescent Pregnancy Prevention Council (CMAPPC).

**SECTION I: COMPOSITION.** The City of Malolos Adolescent Pregnancy Prevention Council I (CMAPPC) shall be composed of the following:

**SECTION II. DUTIES AND FUNCTIONS.** The City of Malolos, Adolescent Pregnancy Prevention Council I (CMAPPC) shall perform the following duties and functions:

- a. Identify factors contributing to the increase of adolescent pregnancy and map out areas of concern in the City where identified factors are concentrated;
- b. Develop, cost and regularly review a Local Program of Action and Investment Plan for the prevention of Adolescents pregnancy in

- Collaboration with relevant government agencies, NGOs and CSOs, and other stakeholders.
- c. Ensure the operationalization and implementation of the Action and Investment Plan;
  - d. Develop to ensure implementation of guidelines and policies necessary for the implementation of this Ordinance;
  - e. Monitor the progress of the response to the City's Teenage/ Adolescent Pregnancy situation and actively seek good practices from all stakeholders;
  - f. Monitor the implementation of Local Program of Action and Investment Plan for the prevention of Adolescents pregnancy, undertake mid-term assessments, including spending assessments, and evaluate its impact;
  - g. Mobilize sources of funds for the implementation and evaluation of the action and Investment Plan;
  - h. Meet at least once every semester, at any venue, the notice for the meeting, including the agenda, shall be sent to the members at least one (1) month before the scheduled meeting, except in case of emergencies, in which case, a 48-hour notice shall be sufficient;
  - i. Identify gaps in the City's response of the part of government agencies and its partners from the civil society and international organizations in order to develop and implement the initial interventions required to address such gaps; and
  - j. Submit the actual accomplishment/progress report on the accomplishments under the Local Program of Action and Investment Plan for the prevention of Adolescent Pregnancy to the Office of the Mayor, Sangguniang Panlungsod, and as needed, to the related/ government agencies.

**SECTION V. SEPARABILITY CLAUSE.** In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.


