**AN ORDER RECONSTITUTING THE BIDS AND AWARDS
COMMITTEE (BAC) AND BAC SECRETARIAT OF THE CITY
GOVERNMENT OF MALOLOS**

WHEREAS, the term of the members of the BAC has expired thus, performing in a hold-over capacity;

WHEREAS, due to expiration of term, there is a need to reconstitute the membership of the BAC and BAC Secretariat to ensure efficiency of the procurement process of the City Government of Malolos;

NOW, THEREFORE, I ATTY. CHRISTIAN D. NATIVIDAD, City Mayor of Malolos, Bulacan, by virtue of powers vested in me, do hereby reconstitute the **Bids and Awards Committee (BAC) and its Secretariat**.

SECTION II. POWERS, FUNCTIONS AND DUTIES. The duties and functions of the Bids and Awards Committee shall be in accordance with Section 12 of the IRR of R.A. 9184 and other pertinent provisions thereof.

SECTION III. TERM OF MEMBERS. Unless sooner removed for a cause, the members shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the City Mayor. Upon expiration of the terms of the current members, they shall continue to exercise their functions until new BAC members are designated.

SECTION IV. HONORARIA OF THE BAC MEMBERS, SECRETARIAT AND ITS STAFF. The BAC Members, Secretariat and TWG members shall receive honoraria, or in lieu thereof, and when applicable, overtime pay, subject to appropriate government auditing rules and regulations. Pursuant to R.A. 9184 and its IRR, the average honoraria per month over one year shall not exceed twenty-five percent (25%) of the basic monthly salary.

SECTION V. FUNDING. The City Government shall provide such amount that is necessary for the effective implementation of R.A. No. 9184.

SECTION VI. REPEALING CLAUSE. All executive orders, rules and regulations inconsistent with this Executive Order are hereby repealed or modified accordingly.

SECTION VIII. EFFECTIVITY. This Executive Order shall take effect immediately upon approval.
