INVITATION TO BID

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2025, intends to apply the sum of:
 - a. **One Million Nine Hundred Sixty-Six Thousand Pesos** (Php 1,966,000.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Upgrading of Pathway and Drainage Canal at Brgy. Liang, City of Malolos**. Source of Fund: 20% Development Fund.
 - b. **Two Million Three Hundred Twenty-Seven Thousand Five Hundred Forty-Five Pesos** (Php 2,327,545.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Rehabilitation of Road at Purok 6 (Back of Paradise), Dakila, City of Malolos**. Source of Fund: 20% Development Fund.
 - c. **Four Million Pesos** (Php 4,000,000.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Upgrading of Road and Drainage Canal at Ngusong Buwaya, Sitio Malanggam, Bulihan City of Malolos**. Source of Fund: 20% Development Fund.
 - d. **Four Million One Hundred Forty-Seven Thousand Five Hundred Fourteen Pesos** (Php 4,147,514.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Upgrading of Basketball Court and Construction of Fence at Brgy. Balayong, City of Malolos**. Source of Fund: 20% Development Fund.
 - e. **One Million Eight Hundred Thousand Pesos** (Php 1,800,000.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Installation, Testing and Commissioning of Main Distribution Panel (MDP) and Airconditioning Panels (ACP)**. Source of Fund: 20% Development Fund.
 - f. **Five Million Pesos** (Php 5,000,000.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Upgrading of Road at Purok Balot, Pamarawan, City of Malolos**. Source of Fund: 20% Development Fund.
 - g. **Six Million Four Hundred Seventy-Five Thousand Five Hundred Forty-Seven Pesos** (Php 6,475,547.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Upgrading of Road at Sitio Pulo, Bulihan, City of Malolos**. Source of Fund: 20% Development Fund.

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from **Engr. Gaudencio A. Carlos** and inspect the Bidding Documents from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from BAC Secretariat Office and upon payment for the Bidding Documents for items a to f : amounting to Five Thousand Pesos (**Php 5,000.00**) and item g: amounting to Ten Thousand Pesos (**Php 10,000.00**)
6. The City Government of Malolos will hold a **Pre-Bid Conference** on **March 10, 2025 (Monday), 10:00 in the morning** at **Malolos and Sports Convention Center Conference Room, McArthur Highway, Brgy. Bulihan, City of Malolos, Province of Bulacan** which shall be open only to all interested parties who have purchased the Bidding Documents.


